It is almost time again for CARS in the PARK, the biggest annual display of vehicles of all models and years and like in 2015 we expect a good turnout for the event. More than 15 000 people attended the event in 2015. Due to demands from our visitors, we will aim to expand on the commercial side of the event in 2016 and therefore invite you to be part of this fantastic day.

### **Requirements of commercial stalls:**

1. At own expense, obtain all permits, give all necessary notices, pay all license fees and comply with all municipal by laws and national laws, rules, ordinances and regulations, relating to public health or applicable to the business carried out under this agreement and will also assume complete and sole liability for the services carried out by the vendor.
2. Comply with applicable laws pertaining to The Basic Conditions of Employment Act, the Occupational Health & Safety Act, the Labour Relations Act, the Employment Equity Act, and any other applicable acts and regulations as required.
3. Conduct any marketing and sales in a professional manner so as not to impact on any competing brand or make of vehicle or accessory.

### **Rules and conditions of participation:**

1. All applications will not necessarily be accepted. The organiser's' decision is final.
2. Payment will not secure stand unless accompanied by written acceptance by the organisers or Exhibition Promoter.
3. You will be notified about the application result on or before the **24<sup>th</sup> of June 2015 and payment then has to be made in full on or before 4th of July 2016.**  
Banking details:
4. **If no or late payment is received the allocation will be null and void and the stand will immediately be given to the next selected** candidate, unless otherwise arranged between you and the organisers.
5. Vendors will be responsible for setting up of their stands as no infrastructure is provided by the organisers.
6. Advertising boards will have to comply with the regulations of the property owners, and all other rules and regulations of the appropriate authorities and stadium/regional rules will be applicable.
7. One vendor's access ticket per 4 square meters rented will be handed to Exhibitors with a maximum of 6 tickets per stand.
8. The organisers, promoters and owners or any of their representatives, shall be indemnified against any loss, accident, or damage that may be incurred by the vendor, its personnel, visitors and guests on signing of this application and/or paying of the required fee.
9. Vehicles on display may be started but no driving around can allowed, unless by prior agreement with and consent from the organisers.
10. You are permitted to sell from your stand, but no promoters canvassing buyers will be allowed.

11. Staff need to display their name tags and/or armbands at all times.

12. On the day of the event contact persons will be nominated to handle any enquiries and this detail will be made available a week before the event.

13. Stands must be setup **before 06h30** on the morning of the event **or before 18h00 the day before the event**

14. Breaking down at the end of the day will only commence at 16h00 and no vehicles can be collected before **17h00 on the day of the event. Break down must be completed before 21h00 on the day of the event any equipment exhibition material must be remove for site except if alternate arrangements were agree with organisers.**

**15. Electricity (10amps) is only available at carports.**
