## 2025 RULES OF THE DAY

#### RIGHT OF ADDMISSION RESERVED

Fees:

Vehicles on show: No charge for the vehicle that will be on show itself, before 08h30

First Two Occupants Free, Rest in vehicle at R150 per person,

Children under 12 enter for free

Vehicles allowed on Track – Pre 2000 as well newer vehicles from

members of participating clubs

Unimogs and Super cars on exhibit exempt as special vehicles

Gates Open 05:15 till 06:00 for Market at the Track vendors

06:00 till 08:30 for vehicle exhibitors free of charge

First Two Occupants Free, Rest in vehicles at R150 per person,

Children under 12 in the vehicle enter for free

08:30 for walk in or assisted spectators

Departure Vendors must stay until 17:00

Vehicle Exhibitors are requested to stay until 15:00 onwards in order

to ensure sound and safe traffic flow.

Spectators: R150 per person at entry gates

R130 per person at iTickets online before 2 August

Children under 12 enter for free

POMC members not exhibiting or not working – full charge

Exhibiting and other club's members not exhibiting – full charge

Exhibitors: 2 persons per vehicle for free

Additional passengers R150 - per person.

Children under 12 free entrance

Proof of Membership Entering with a post 2000 vehicle will require

valid in-date proof of Club membership or entrance permit

Entry WILL BE refused if membership or entrance permit cannot be

shown

Special Invites: Free of charge with proof of invite

**Use Gate 2 for Entry** 

Must report at the Collection office just inside the main gate with

documentation to proof stand allocation and payment.

After setup of stand vehicles and trailers must be moved to parking

opposite Go-kart track

**Trailers and Club Support Vehicles** 

**Trailers:** All trailers must be parked in the Trailer Park

NO EXCEPTION ALLOWED

**Support Vehicles**: Permission must be obtained from the POMC Organiser one week

before Cars in the Park (by Friday 25 July 2025)

.

Such vehicles, without permission, will be refused entry to the Track

Support vehicles must be parked in the Trailer Park after off-loading.

NO EXCEPTION ALLOWED

### **Entry Gates to track:**

**Gate 1:** At the Mercedes Clubhouse

**Exhibitors and Pedestrians** 

Vehicle exhibitors only for stands 1 to 60

NO VENDORS ARE ALLOWED TO ENTER AT THIS GATE

Gate 2: Next to Skid pan

**Exhibitors and Pedestrians** 

Vendors enter only at this gate before 6h00

Recommended for stands numbers 1 to 60

Gate 4: Easterly Gate - at bottom of the track, next to main road

**Exhibitors and Pedestrians** 

NO VENDORS ARE ALLOWED TO ENTER AT THIS GATE

Recommended for pits and stands 82 to 117

# **Exhibitors (Club Members and Non-Club Members):**

Clubs: Per demarcated area

As per map – Use the gate closest to the demarcated club stand

Non-clubs: Past the pits – round the hairpin

Northern "straight" parking area to the left and right

#### **Access and Exit Roads:**

Main entry: One-way until 12h00 up to Mercedes Club House

**Exhibitors for Gate 1 and Gate 2 must keep right lane** 

Spectators use left lane to parking area POMC members exhibiting enter at Gate 1

Exit: Drive-in parking - use the western exit (new) via Erasmia to M26

From inside track use Gate 4 or Gate 1

When exiting via Gate 1 turn right to drive-in parking and use west

exit (new) via Erasmia to M26.

## **General Rules for the Day**

- Driving around the track will be strictly regulated AS A SAFETY PRECAUTION for pedestrians who have right of way
- When entering, take the shortest route (on track) to stand and park
- Being or driving under the influence or reckless driving will be directed to the SAPS to deal with
- Speeding will not be tolerated and any person found to be speeding, spinning or attempt to do it, will be escorted from the track, regardless
- No open fires will be allowed, only gas braai or enclosed fires is allowed. Visible fire extinguishing equipment will be required at all times
  - o DO NOT DISPOSE OF HOT ASH INTO ON-TRACK DUSTBINS IT IS A FIRE HAZARD
- Zwartkops has a liquor license so please do not bring your own liquor
- Revving of engines is not allowed without written permission from POMC
- No "FOR SALE" or "TO RENT" signs and boot sales are allowed on track without permission. An area will be allocated opposite the go kart track for vehicles for sale (Stand number 124). Contact organiser to arrange parking.
  - o Driver and passengers of for sale vehicles will have to pay entrance fee.
- Vehicle Exhibitors are not allowed to sell or swap any items without permission obtained from the organisers before 25th July 2025
- Stay out of the sand pits as you will get stuck
