Following on the success in 2025 we believe that the **44th CARS *in the* PARK** in 2026 will be even better. Be a part of this successful event – applications for stalls in the Market *at the* Track is now open.

Responsibility of vendors:

THE VENDOR SHALL:

1. Provide products or services of a satisfactory quality and market related prices to all parties.
2. Maintain a clean, safe, and healthy environment and ensure that the vendor's area is left as found.
3. **At own expense**, obtain all permits, give all necessary notices, pay all license fees, and comply with all the City of Tshwane Municipal by-laws and national laws, rules, ordinances, and regulations, relating to public health or applicable to the business conducted under this agreement and will also assume complete and sole liability for the services offered by the vendor.
4. **Food vendors** must also:
 - 4.1 Provide with their application a copy of:
 - Tshwane certificate of acceptability for food vendors
 - Tshwane undertaking to abide to Tshwane's conditions
 - Proof of attending food handling training
 - Copy of ID
 - Menu with prices
 - 4.2 Display menu with prices at stall.
 - 4.3 Use a ground sheet where food vendors do not use a Food Trailer.
 - 4.4 **Have a 4.5 kg fire extinguisher as minimum standard required.**
 - 4.5 Provide own electricity for heating or cooling.
 - 4.6 Vendors must clean up the area of the stand **before leaving** the event and no oil, fat spillage and waste are to be left on the stand.

5. Comply with applicable laws pertaining to The Basic Conditions of Employment Act, the Occupation Health & Safety Act, the Labour Relations Act, the Employment Equity Act, and any other applicable acts and regulations as required.

Cost of stalls (Stand costs depend on location):

Carport:	3m x 6m =	R 2 200, - to R 4 500, - depending on location
	6m x 6m =	R 3 500, - to R 8 000, - depending on location
Food stalls:	R 2 500, - to R 10 000, - depending on location and size	
Open stand:	4m x 4m =	R 1 800, - to R 12 000, - depending on location
Open Stand:	8m x 4m =	R 3 200, - to R20 000, - depending on location

Vendors are required to supply your own gazebo or similar structure that is properly secured with weights. The standard size for open stalls is 4m x 4m. If more space is required, you need to apply for additional space, and this could have a cost impact.

Ensure that you provide the correct dimensions of your gazebo or mobile that enough space will be allocated to you.

If your gazebo or mobile does not fit in the dimensions provided you will not be allowed to set up and no refund will be made.

No electricity will be supplied to the open or mobile stalls.

A limited number of carports have electricity supply. The supply is 5 amp, which is adequate for a card machine.

If you require a constant, strong electricity supply, you will have to supply your own generator. (For example, if you need to warm food up, cook or bake).

None of the stalls have partitioning. If partitions are required for privacy or display purposes, you will have to provide the necessary.

Rules and conditions of participation:

1. Not all applications will be automatically approved, and the organizer's decision is final.
2. Payment will only secure stand if accompanied by written acceptance from the organizers or Exhibition Promoter.
3. You will be notified about the result of your application within 14 days after receipt of the application. The deposit will be payable within 30 days of invoice.

Banking details will be on the invoice. It is important to send the proof with payment, **with the correct reference number**, to the organizer.

Stands will be allocated after receipt of the required deposit.

Payment must be made in full on or before 13th of June, after which a stand number will be confirmed.

4. If no or past due date payment is received the allocation will be invalid and the stand will immediately be given to the next approved applicant, unless otherwise arranged between you and the organisers.

5. Vendors will be responsible for setting up of their stands.

6. Advertising boards will have to comply with the regulations of the property owners, and all other rules and regulations of the appropriate authorities and stadium/regional rules will be applicable.

7. Each vendor will receive two tickets. Additional tickets can be purchased at R150 per ticket.

8. Participation is at your own risk. The organizers, promoters, and owners or any of their representatives shall be indemnified against any loss, accident, or damage that may be incurred by the vendor, its personnel, visitors, and guests on signing of this application and/or paying of the required fee.

9. Vendor's vehicles are only allowed to park in the trailer park and not on the track or pit area.

10. Before and during the event, vendors are only allowed to sell from their assigned stand.

11. Vendors and their staff must always display their name tags and/or armbands.

12. On the day of the event contact people will be nominated to manage any enquiries and this detail will be made available a week before the event.

13. Set-up of vendor stands -must be completed **before 7:15** on the morning of the event.

Gates open from 5:15 till 7:00 on the morning of the event for deliveries.

Late arrivals will not be allowed to drive to their stands. Stands, equipment and displays will have to be carried to the stand.

Please report to the Collection Office at the Main Entrance next to R55.

If you arrive early, please park in the designated parking area at the Collection Office.

Do not queue in front of the gate.

Dismantling stalls will only commence at 16:00 and no vehicles will be allowed on the track for collection before 17:00.

14. Arrangement can be made with the organizer to set up from 13:00 till 16:30 on the day before the event
